MONTHLY MEETING

MINUTES FOR JUNE 11, 2011

The sun rose once again upon another picture perfect day here in our desert paradise, and the monthly meeting of the RCENO Board of Advisors descended upon the gorgeous home of BOA member Terry Towne.

The meeting continued with Rick updating us on the elections

of the Board of Advisors for our organization:

- Donna Chaban was elected for a second term as vice president;

- Dean Nicastro was re-elected as Treasurer;

Joseph then motioned to give \$3000.00 to Vista Del Monte School for them to use as they see fit; Robert seconded. Again, the motion passed unanimously.
