Racquet Club Road Traffic Calming

After Joseph gave a review of the history of this project and how it had been put on hold new neighbor Michael Alba Huizar reported that he has been in contact with the city regarding the safety of high-speed drivers on Racquet Club Road. He has compiled data on traffic stats on Racquet Club and elsewhere in the city. We agreed that we would actively work to get the city to put safety measures in place such as the "road diet" that was planned for the street a few years back i.e. reducing it to one lane each way and putting in bike lanes. Denny agreed to find out from the city the process for requesting the project and all agreed that we should contact other NORGs through which Racquet Club Road travels. Those

include: Desert Park Estates, Ranch Club Estates, and Gene Autry. Denny will report his findings at the December meeting, and we will discuss our next steps then.

Palm Springs High School Scholarship

Joseph reported on the progress of our scholarship recipient. Mady Hampton has successfully completed her first year at Northern Arizona University. She earned a 3.38 GPA semester one and a 3.10 GPA semester two. She has enrolled and signed up for a full load of classes for the 2020-2021 school year. Joseph sent this year's stipend of \$2,000 to the Palm Springs High School's Office of College & Career Guidance and they will make the payment to Ms. Hampton.
