RCENO Tree at Victoria Park

Kitty needed some information from the board regarding the upcoming tree planting. We agreed to the following:

- The plaque will be dated 2020 as that is the 50th anniversary of Earth Day.
- It will have the RCENO logo on it.
- Robert will deliver her the check of \$1,250.00 after Kitty finds out to whom
 it should be written.

 We have tentatively scheduled April 24 at 10:00AM for a dedication at the tree site. When the date is certain Joseph will send out a blast to the neighbors.

PS Pedestrian Plan Group

Michael reported to the board that the city is holding a virtual walk audit of our neighborhood on Wednesday, March 17, at 4:00pm. In addition, he showed us an online traffic survey and an interactive map survey. He will send Joseph a write-up to accompany an email blast to the neighborhood that Joseph will do. RCENO has submitted a formal request that Racquet Club Road be put on a road diet. Dennis Woods emphasized the importance of this being a community organizing event.

Old Business / New Business / Other / Adjournment

Our councilmember took questions from the group.

- A question was raised regarding the abandoned steel home. Woods recommended it be reported with the My PS app.
- The plot of land at Indian and San Rafael has been approved for an affordable housing project.
- A Tower Market is under consideration for the corner of San Rafael and Indian.
- Both the Andaz and Tova Hotel projects have been stalled indefinitely as both developers are in bankruptcy. Woods reported that the city will address the project through the courts if it isn't resolved by the developers in a timely manner.
- The new post office will be opening soon, and Riverside County is constructing a new health center at Tahquitz and Sunrise.
- The city is trying to halt the delivery of homeless into Palm Springs.
- Woods said that he will look into the communications issue between the police department and RCE regarding Jenny's murder.
- Eric made a motion that RCENO present the Palm Springs Animal Shelter a \$1,000 donation in the memory of neighbor, friend, and board member Jenny Dillon. Joseph seconded the motion; all were in favor.
