Robert and Dean will create a fiscal budget to submit to the Board at the August meeting for discussion and approval.

<u>By-Law Review</u>

Terry would like a thorough review of our by-laws. She will ask Lauren if she would work on this with her to present to a future BOA meeting.

RCENO Tax-Exempt

It was agreed that we need some clarifications. Do we need a California nonprofit tax status? Do we need a business license? Dean will consult with his accountant.

D&O Insurance

It was agreed that we need to obtain directors and officers' liability coverage. Dennis will look into it and bring quotes to our August meeting.

Neighborhood Expansion

Some neighbors outside of our designated boundaries want to join RCENO. The board agreed that our neighborhood should remain within the existing boundaries. Terry will draft a letter to those wishing to join that we are not interested in expanding and suggesting that they form their own NORG.

Block Party

The block party will be held on October 3, 2015 between 4:00PM and 7:00PM on Ace Circle off of Alexander Way. Donna made a motion that we offer Kal David and Lauri Bono a \$200 stipend to play for us. Terry seconded it and all voted in favor. Robert will look into finding a BBQ caterer. For beverages we decided to offer water, lemonade, keg beer and possibly individual containers of wine. We will rent tables and chairs.
