Approval of June Minutes

Denny made a motion to approve the minutes from the BOA meeting of June 8, 2019. Donna seconded the motion; all voted in favor, the minutes were approved.

Financial Report

Dean reported that we have \$49,377.09 in our general account and \$5,649.87 in our Visa account. Dean also presented a card that Mady sent us and Jenny read it. Our D&O insurance is due October 11. It will roughly be \$1,500 for the year.

Officer Report

Denny reported from the ONE-PS meeting telling us that most everything covered at the meeting is in the weekly ONI Reports. He showed us a battery disposal box that we can get from the city. Volunteers are needed for ONE-PS fall home tour.

Guest Speaker: Dennis Woods- District 2 Candidate

Dennis Woods, candidate for city council, district 2 spoke to us and then held a Q&A session. His main concerns for the city are:

- Homeless programs
- Low income and affordable housing
- The city's general plan.

His main concerns for District 2 are:

- Blight at the entrance to the city along 111
- Pedestrian safety.

Board members and neighbors expressed their concerns:

- Coachella Valley Volunteers in Medicine CVVIM needs a Palm Springs branch.
- The speed limit needs to be reduced on Palm Canyon Drive at the north end.
- Many streets are in disrepair.
- There is speeding on Racquet Club Drive, what happened to the road diet that we were supposed to have had?

Mr. Woods is asking for volunteers to host house parties for his campaign. We will not be endorsing any one candidate in this race.

Home Tour

Our 2020 home tour will take place on the first weekend of Modernism on Saturday, February 15th. We have one or two houses and Robert pleaded with the group to find houses. Denny said that he would write up a handout to present to homeowners who might be interested in showcasing their home. We will come to the September meeting ready to volunteer for the various roles needed for the tour.

RCE Address Stencil

Robert showed us the revised address stencil. We need to get 100 people to volunteer to have one placed on their curb. Robert will write up a flyer and send it to Joseph who will push it out to the neighbors eliciting participation in the program.

Block Party

The block party will be held on October 12 from 4:00-6:00PM. We are looking for a new caterer this year. Several board members will get quotes for food for 50 people with all supplies provided. Joseph will order the table and chairs using the same order as before. Robert will look into getting the Ben & Jerry's ice cream cart.
